


Bailiff




Makes sure the courtroom rules are obeyed.

Guard



A police officer who helps keep the courtroom a safe place.

Witness




A person who saw the crime happen or who knows something about the crime.

The lawyer who helps the person accused of breaking the law. He or she asks the witness questions in court.


Tell What Really Happened




The truth is what happened. It is right. It is good to tell the truth.

Then:


You will go into the courtroom and the judge will ask you to promise to tell the truth.

Draw a picture of yourself on the Witness Chair


Later on, you may have to come back to court to tell a jury what happened.
