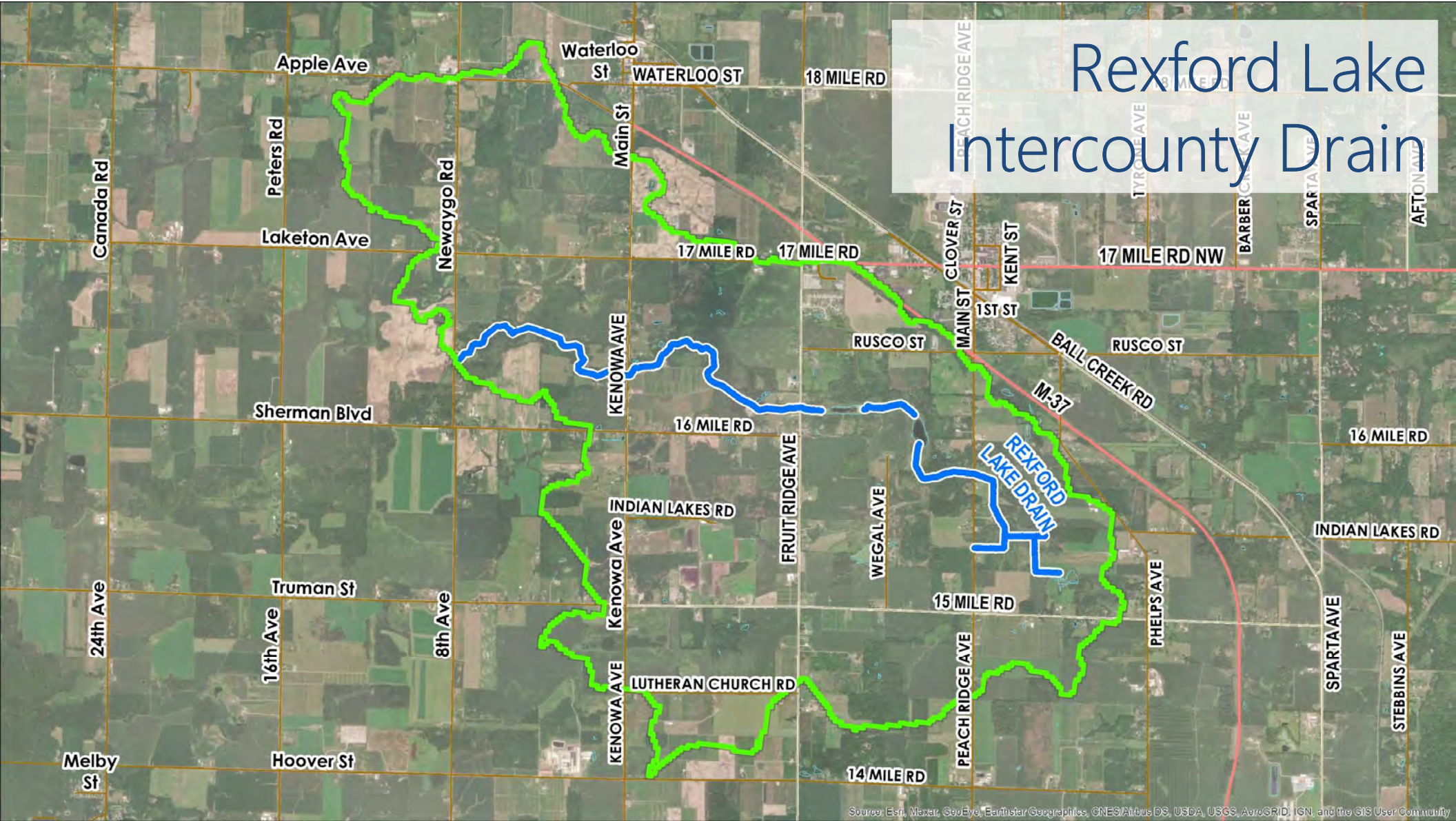

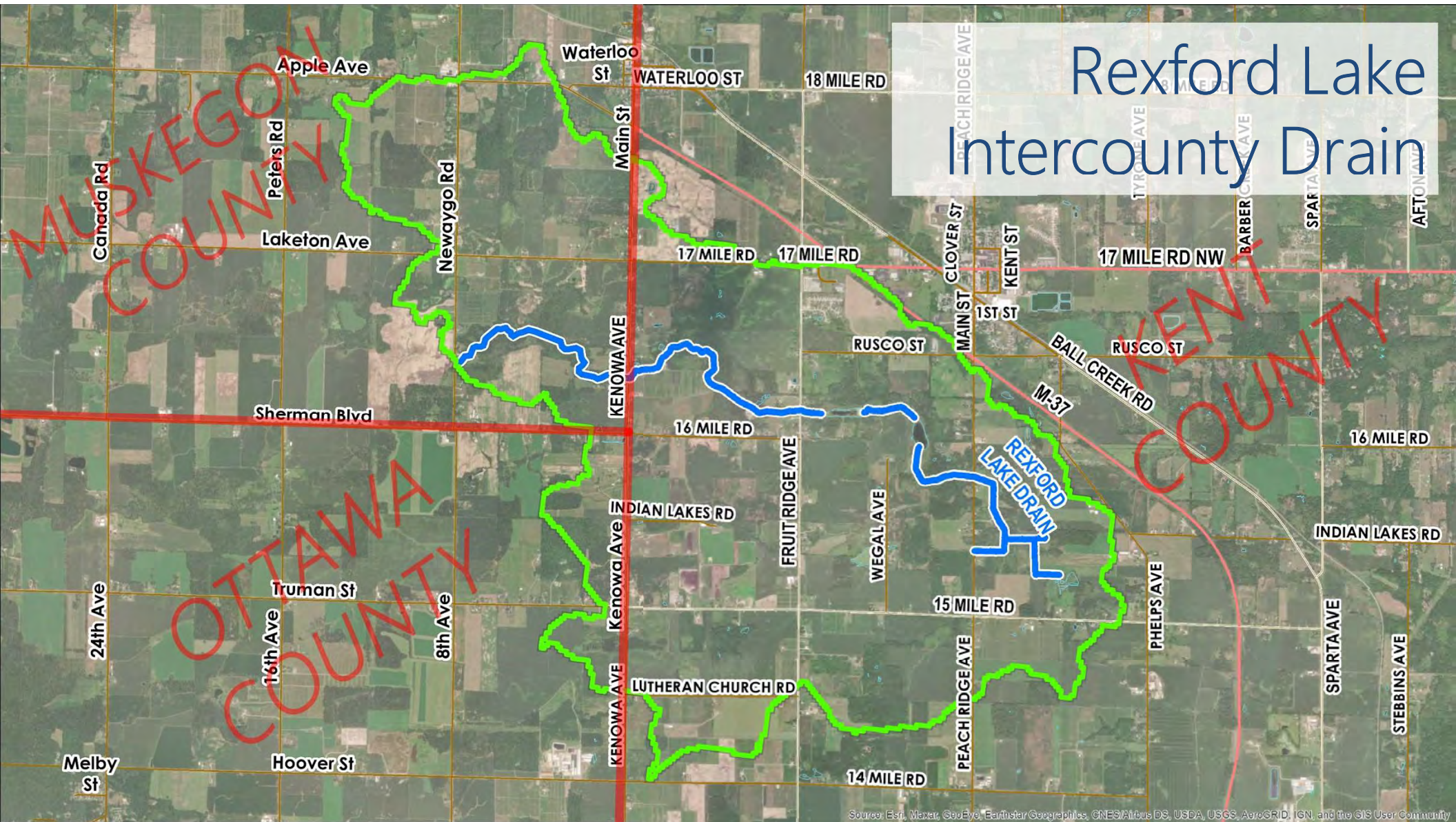


Rexford Lake Intercounty Drain

Petition

- Received September 2023 requesting maintenance and extension of the drain.
- Function of the meeting is ***to determine whether a problem exists and whether it is practical to move to next steps.***
- ***No survey work engineering work has been completed.*** In the interest of efficiency and economy, the Drain Code requires a finding of ***Practicability*** before expending funds on engineering.
- This hearing ***does not*** address scope or corresponding costs of any potential project.
- No project has been decided; ***no assessments known.***



REXFORD LAKE INTERCOUNTY DRAIN

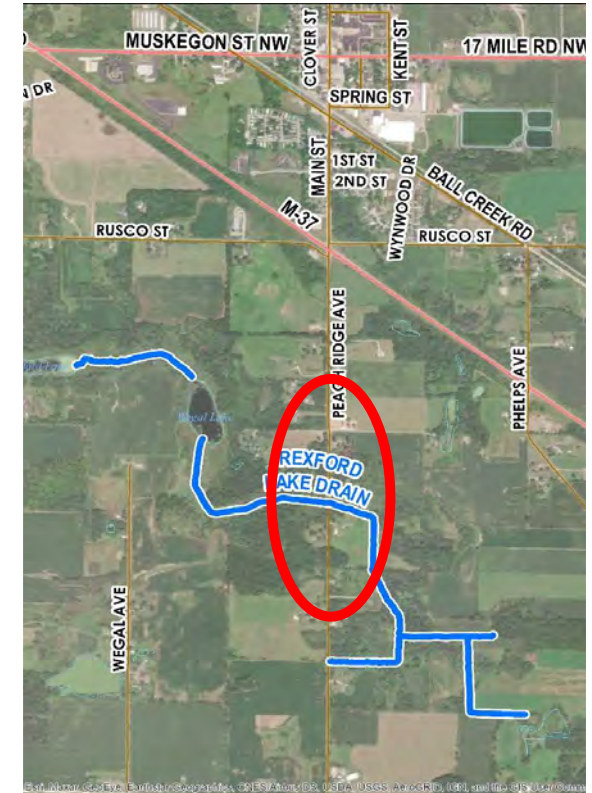
This petition is signed by at least five (5) freeholders whose lands shall be liable for assessment for benefits of the work requested.

Signers acknowledge and understand that this Petition may be circulated and signed in counterparts, and that all such counterparts together constitute a single Petition.

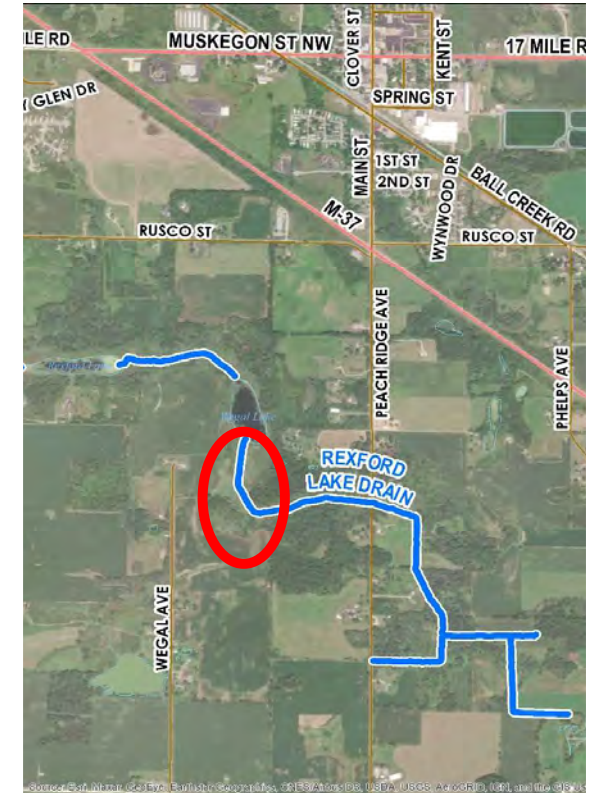

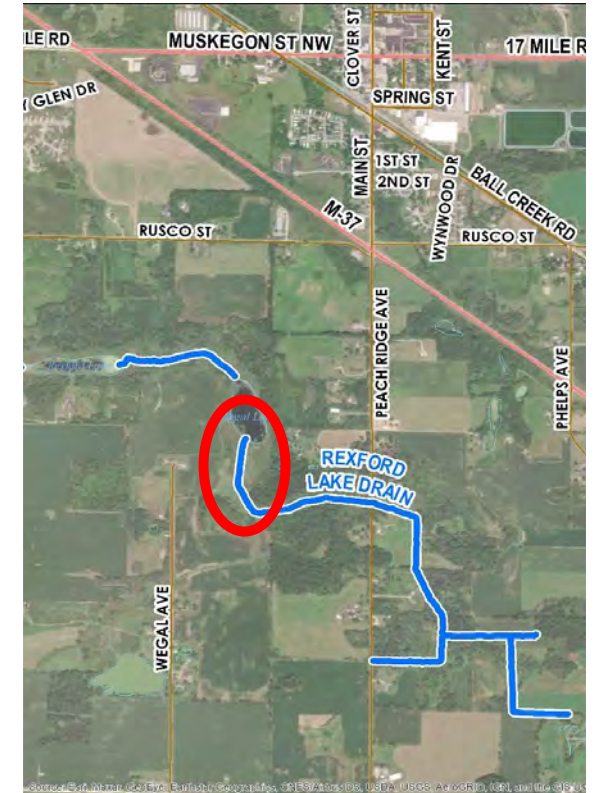

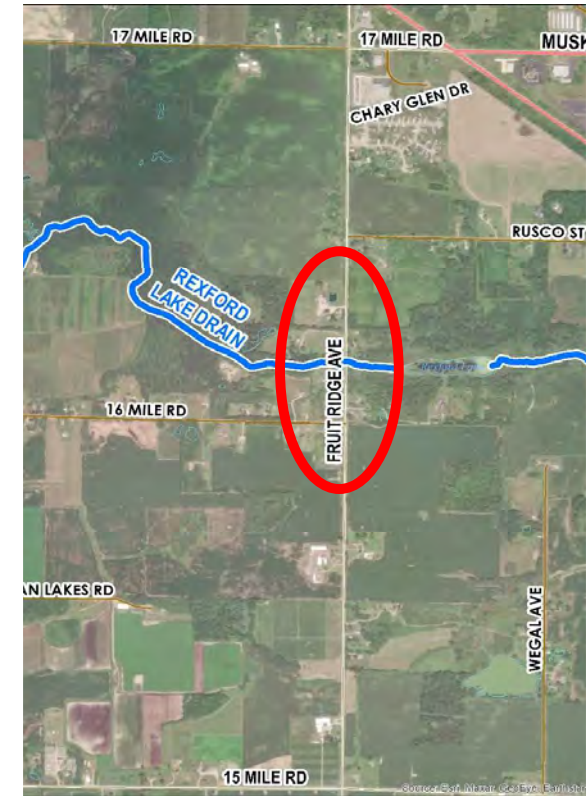

Inspection Conclusions

- Channel from Peach Ridge Ave to Fruit Ridge Ave is nearly flat (0.02%)
- Significant sediment accumulation from downstream of Fruit Ridge Avenue through Peach Ridge Avenue holding water east of Peach Ridge.
- Road Commission has history of regularly closing Peach Ridge Avenue due to overtopping.
- Potential extension for additional cleanout requested on upper end (east end towards 15 Mile Road)
- Good flow and free culverts at Kenowa Avenue

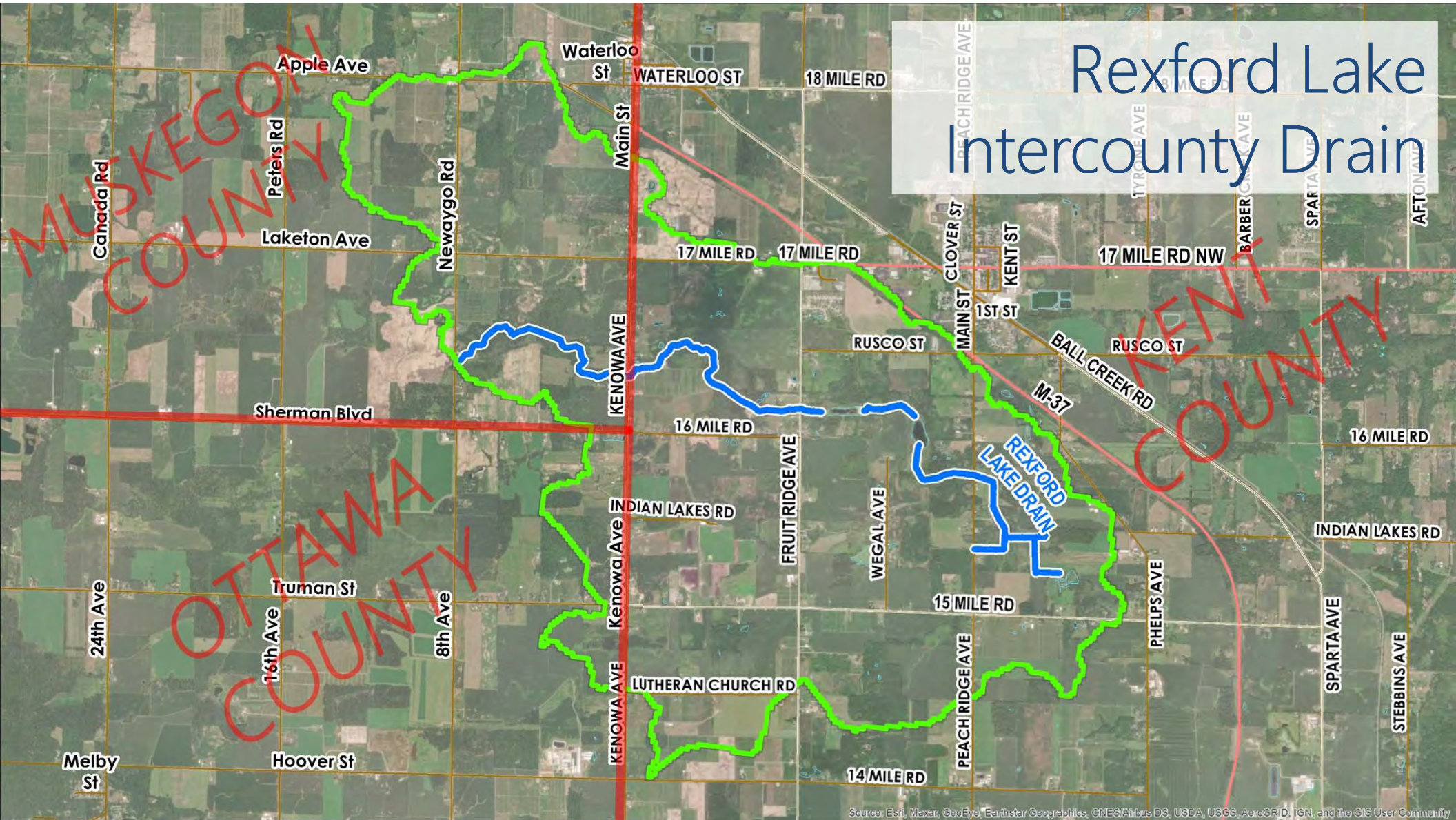
