DESCRIPTION OF INCIDENT:

On March 8th 2015 The Kent County Sheriff Department responded to a PI accident on 6 Mile Rd and Baumhoff Ave in Alpine Township.

When rescue and deputies arrived they found the 05 Pontiac heavily damaged with 2 subjects trapped inside. Fire rescue were able to free the subjects after using the jaws of life to gain access to them. The back seat passenger was not injured. Both the driver and front seat passenger were transported to Spectrum Hospital for serious injuries. The other driver wasnt injured.

It appears vehicle #1 the 05 Pontiac was traveling SB Baumhoff and failed to yield the right a way to the westbound vehicle #2. The accident is still under investigation with our traffic division.
