DESCRIPTION OF INCIDENT:

On 06/13/15 at approximately 2308 hours, The Kent County Sheriff's Department responded to a crash involving an ATV and a passenger car on Red Pine Dr NW and 20 Mile Rd NW in Tyrone Township, Kent County, MI. Rockford Ambulance, Life Ambulance and Kent City Fire Rescur responded to the scene as well. The ATV was traveling westbound on 20 Mile Rd NW when he failed to stop for the stop sign and collided with a passenger car traveling southbound on Red Pine Dr NW. The driver of the ATV suffered fatal injuries as a result of the accident and later died at Spectrum Health Butterworth. Alcohol is believed to be a factor in the accident. This accident is still under investigation by the Kent County Sheriff's Department.
