### DESCRIPTION OF INCIDENT:

On 10/25/2015 at 3:41pm, the Kent County Sheriff's Office was dispatched to the intersection of 108th ST SE and Hanna Lake Ave SE regarding a two vehicle, personal injury crash. A northbound Chevy Impala was struck by a westbound Dodge Caravan. The driver of the Impala, Alexandria Rogers, was treated on scene and transported by AEROMED to Spectrum Butterworth Hospital with life threatening injuries. The driver and passengers in the Dodge Caravan, were unharmed aside from a 2 year old female, who suffered minor injuries. The crash is still under investigation, and it is unknown if any medical conditions may have played a role. Alcohol is not believed to be a factor in the crash. The driver of the Impala was unrestrained during the time of the accident.
