NEW! CHILD SUPPORT FORMULA CHANGES COMING 2025

A new child support formula will launch in Michigan in 2025. Here are a couple of the significant changes:

Ordinary Medical Expense (OME) decreases to \$200 per child annually (from \$454 per child):

Old Formula

New Formula

Child Care Expense ending date is presumed to end the last day of the month *in which* the child turns 13.

FORGIVENESS OF BIRTH EXPENSES IN 2025

In 2025, the State of Michigan will be forgiving existing child support arrears for birth expenses. These expenses are the child support obligations in place to cover the cost of a child's birth if that birth was covered by Medicaid. If you have eligible expenses, you will receive a letter in the mail. This forgiveness program does not eliminate any past due support owed to the other parent. Questions?
