<u>4-24-08-40 – SIDWELL CONTRACT RENEWAL / BUREAU OF EQUALIZATION</u>

WHEREAS, the County has contracted with the Sidwell Company for approximately 40 years for the production of a CD edition of atlases that Sidwell leases to an estimated 30 institutional clients in Kent County. Sidwell pays the County a royalty of 20 percent for their limited use of the map for lease sales. The current contract was to expire July 2008; and

WHEREAS, Bureau of Equalization staff is recommending that the contract, as amended July 27, 2006, be renewed for an additional one year period after which time it is anticipated that the County will be able to provide access to the maps through its GIS system.

NOW THEREFORE BE IT RESOLVED that the Board of Commissioners approves the contract agreement with The Sidwell Company for sales and marketing of Kent County tax maps.

4-24-08-41 – QUIT CLAIM DEED CORRECTION / ROAD COMMISSION

WHEREAS, on October 2, 2007, the City of Wyoming inadvertently conveyed a right-of-way to Kent County, which right should properly vest in the Kent County Road Commission, and

WHEREAS, the Road Commission requested the County to correct the erroneous conveyance, quit claim title, right, and interest over the property to them, and

WHEREAS, pursuant to review of the Road Commission's request and related property records, Corporate Counsel has approved the grant of quit claim deed.

NOW THEREFORE BE IT RESOLVED that the Chair, or vice-chair, in his absence, be hereby authorized and directed to execute the quit claim deed.

4-24-08-42 – APPROVE THE COMMUNITY DEVELOPMENT ANNUAL ACTION PLAN AND BUDGET AMENDMENT / COMMUNITY DEVELOPMENT

WHEREAS, Kent County has qualified as an Urban County, which makes it eligible to receive funds from the US Department of Housing and Urban Development (HUD) for its 27th year as an entitlement community; and

WHEREAS, the five-year Consolidated Plan for July 1, 2005, through June 30, 2010, consists of a needs assessment, market analysis and related goals and objectives, and is a prerequisite of obtaining Community Development Block Grant (CDBG), HOME Investment Partnership (HOME), and American Dream Down payment Initiative (ADDI) funding from HUD; and

WHEREAS, the grant application, referred to as the Annual Action Plan, contains a description and budget for CDBG, HOME, and ADDI-funded activities proposed to be undertaken between July 1, 2008, and June 30, 2009, including CDBG projects requested by 33 local units of government as well as one project requested by the Kent County Parks Department for improvements at Dwight Lydell Park (\$25,000); and

WHEREAS, the application seeks \$2,219,778 in funding that includes CDBG \$1,539,669, HOME \$598,980, ADDI \$6,129, and recognizes an additional \$75,000 anticipated as income from the CDBG Housing Rehabilitation Program.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Commissioners approve the Housing and Community Development Annual Action Plan for July 1, 2008, through June 30, 2009; and

BE IT FURTHER RESOLVED that the Board of Commissioners authorize the Board Chair to sign all documents related to the plan; and

BE IT FURTHER RESOLVED that the Board of Commissioners hereby appropriates \$2,219,778 in estimated revenues to the 2008-09 CDBG, HOME, and ADDI programs contingent upon award and execution of a contract.

4-24-08-44 – SCHOOL INSPECTION FEES / HEALTH DEPARTMENT

WHEREAS, legislation passed in 2007 allows local Health Departments to charge school districts for kitchen inspections at the same rate they charge local restaurants; and

WHEREAS, prior to this legislation school districts were exempt from any inspection fees; and

WHEREAS, there are less than two months left in the current school year; and WHEREAS, many school districts in Kent County will struggle to pay these fees this year because school lunch programs are self supporting and operate on tight budgets; and

WHEREAS, HB 5951 was introduced into the Michigan House of Representatives by Rep. Michael Sak on April 8, 2008, to allow school district to be charged \$20 per kitchen per year; and

WHEREAS, the Kent County Health Department is not mandated to charge fees for kitchen inspections to school districts.

NOW, THEREFORE, BE IT RESOLVED, that the Kent County Board of Commissioners direct the Kent County Health Department to waive the assessment of these optional inspection fees until at least January 1, 2009; and

BE IT FURTHER RESOLVED, that should any fees be collected prior to passage of this resolution by the Kent County Board of Commissioners, the Health Department will refund school districts for any inspections performed prior to January 1, 2009.
