7. Report of the President: None

8. Report of the Director:

a. Gustavo updated the board on the status of the transfer request materials, noting that all documents have been submitted and that they are now awaiting final approval from HUD. An updated resolution from MSHDA was received last month, and Gustavo outlined the communication strategy that will be implemented once they receive notice to proceed. If the schedule remains on track, the transition is anticipated to take effect in January 2025; however, if there are delays, the transfer date may be pushed to July 2025. To ensure a smooth transition, the team has engaged with the County's communications department and MSHDA to prepare necessary information. Additionally, Gustavo reported that the HCV team is preparing for an audit scheduled for this month, exploring options for file transfers, whether digitally or in physical copies. Stephen commented that this audit is expected to be the last external audit for the program. Gustavo also addressed the VA's request for HUD VASH vouchers to be handled by a specific MSHDA team experienced in this area, noting that currently only HUD VASH vouchers are being issued. Clients actively searching for housing have a limited timeframe of 120 days to secure a rental; if they are unsuccessful, they must request a 30-day extension for extenuating circumstances. Furthermore, Gustavo shared insights from a recent meeting with Commissioner Lunger and County Administrator Al Vanderberg regarding the future direction of the Housing Commission. There are funding opportunities available for housing initiatives, and the department plans to engage in community efforts to retain housing stock.

a. Stephen noted that there was not a financial report prepared for the interim meeting. The financial report will be discussed at the regular November meeting.
