DESCRIPTION OF INCIDENT:

On 5/19/15 at approximately 9:10am the Kent County Sheriff Dept. was dispatched to an accident in the 8000 block of Cascade Rd SE, Cascade Twp.

Upon arrival deputies located a 2000, Chrysler, Town and Country mini van that had crashed into a tree.

The vehicle was occupied by one person, a 66 year old female from the Grand Rapids area. The victim suffered fatal injuries in the crash.

A witness to the accident stated that the vehicle had been Westbound on Cascade Rd when it drifted left of center, went off the roadway and struck a tree.

The accident remains under investigation at this time. Name of the victim is being withheld pending notification of family members.
