DESCRIPTION OF INCIDENT:

On 8/28/18 at 1039 hours, the Kent County Sheriff's Office responded to an accident with injuries that occurred on Plainfield Ave at 5 Mile Rd in Plainfield Township.

The preliminary investigation revealed a 2016 Chevy Silverado was northbound on Plainfield Ave when it was struck by a 1997 Kenworth excavating dump truck that was southbound on Plainfield Ave that had crossed the centerline.

The Kenworth was driven by 31 year old Jack Crandall of Bailey, MI who was uninjured. The Silverado was driven by 63 year old Paul Krupp of Plainfield Township. Krupp was transported by Life Ambulance to Spectrum Downtown with life threatening injuries after an extended extrication from his vehicle.

Assisting on the scene was Plainfield Fire, Grand Rapids Fire, MSP Motor Carrier and Life Ambulance.

Both drivers were belted and alcohol is not a factor. The accident is still under investigation.

Next of kin has been notified and the names may be released.
